Our New Patron 2023



Wilhelmena (Willi) Smith is South West Counselling's new Patron. Board Chair, Gloria Ross, posed some questions to Willi on accepting this position. Gloria writes: "Reading through Willi's written responses, I was struck by the fact that much of the organisation's ethos today is like its foundations 40 years-ago.

Willi, along with her husband George, began the Mobile Counselling Service on 29th May 1982. Their office, home and counselling service were based in a 3-tonne truck which was especially modified for the service which would take in much of West Australia. The original objectives were:

To provide counselling welfare and charitable facilities and services for the relief of suffering, distress and poverty, and to meet the needs of and provide help for individuals requiring

assistance in the community generally, and without restriction, particularly in remote areas by means of staff accommodated in mobile living facilities.

Willi and George saw their first task was to test out the need for counselling and group work in remote areas of W.A.

It was a new beginning for both Willi and George in every way, after they had always lived and worked in the Perth metropolitan area. They had committed themselves to helping people who suffered from stress, emotional pain and often loneliness.

After three years in the north-west and then five years in the south-west, having worked with thousands of men and women to help them change their problems into possibilities the vision was now a reality.

From May 1982 to May 1990 Willi and George worked in over 60 communities from Alice Springs to Wyndham! When you read George's book *Possibilities from Dream to Destination* it is amazing to realise how much ground they covered and in fact their new approach to offering a mobile service. The counselling was free, confidential and professional. I was particularly struck by the goals of the counselling service they offered (p.148 *Possibilities from Dreams to Destination*-Serving the South West). *Counselling:*

Enhances Relationships Enriches Communication Resolves Grief *Teaches Important Living Skills Relieves Social & Emotional Stress Introduces new resources* Diffuses Confusion Provides Information In a summary of her evaluation Jenny Monson in *Possibilities and Dreams p.171* states:

The clients of Mobile Counselling described very clearly the impact of being listened to, cared about, and treated with optimism and honesty in a relationship which bore no judgement. These were triggers to their change and growth and they can be applied equally successfully to group work and community development approaches. It is extremely heartening to know that over 40 years on South West Counselling still provides all the above to its client group.

The on-going success of South West Counselling has grown from a vision that was begun 40 years ago to the present day with South West Counselling described by Willi as *a dream come true!*

Willi is an amazing woman. When asked what she felt was her greatest achievement she said: *My greatest achievement in life is still a work in progress – to be a loving kind person, who is genuine, honest and humble.*

Willi stresses that to work successfully as a counsellor it is important to be non-judgemental and to respect humanity. It is easy to judge. It is more difficult to understand. Understanding requires compassion, patience, and a willingness to believe that good hearts sometimes make poor choices or the methods by which to solve or approach an issue. Willi underpins the need to learn and practice skilled active listening; emphasising that by being judgmental we separate, by understanding we grow. It is uplifting to know that the counsellors and all the staff at South West Counselling are all these things.

Willi has accomplished much over her busy life, from working as a mobile counsellor to applying those skills to lone father's support services, establishing various counselling services and working with various support groups.

Talking to Willi and reading what she has written, many of the same issues and areas that affect the human condition – relationships, positive communication and loneliness in all age groups are still problematic today and are affecting our society, as they possibly always will. Social stresses today encompass the impact and prevalence of social media. This in turn can affect self-esteem and the unrealistic expectations placed on society for young women and men. Further, this affects relationships, home life, listening and communicating within all relationships within a family and society in general. The above stresses the need for organisations such as South West Counselling with its strong client focus and mandate to enhance the wellbeing of individuals, families and children in the South West. So, the work still goes on, albeit in a different form, but still with the care and transparency that will see it through to another generation of compassionate care and support for the people of the South-West.

Chairperson's Report

I am now celebrating my third year as Chair for SWCI. As I look back, I realise that this has been a somewhat calmer year than the previous two, due to Covid.

As a board we work hard to maintain a consistent level of support for our CEO Karen Sommerville and this in turn supports the excellent counselling and administration staff of the organisation. I would like to take this opportunity to thank all of our counselling staff and our excellent administration team – without your professionalism and willingness to go the "extra mile" SWCI would not run as smoothly and efficiently as it does.

The Board's role is essentially to take on that of an oversight role, to support our CEO in providing strategic policy and business direction, reviewing and monitoring risk, financial and operational performance, and accountability to relevant parties. Meetings are now held every two months as we unanimously felt we could deal with all business within that time frame. If necessary, Karen can call an emergency meeting. Karen and I continue to meet each month to ensure continuity.

During the year the Board has highlighted the importance of having robust and consistently highquality internal practices, processes and outcomes. The board consists of Jennie Parrin, Arvind Pillay, the Hon Libby Mettam, Michael Brown, Jodie Richards, Elizabeth McGovern, Dr Tess Martin and myself, Gloria Ross, as Chair. With backgrounds in finance and accounting, insurance, family law, community service management, education, counselling, senior public service and politics, you can be assured that decisions made by the Board underpin a wealth of experience and interest in community support.

Unfortunately – for the Board, our previous treasurer Steve Carr has resigned, his expertise, eye for detail and genuine care and support for our client group and staff, along with a fine sense of humour and positivity, will be sorely missed. Steve and his wife Kay will now be traveling and generally enjoying a well-earned rest.

As we celebrate over forty years of supporting the community, we have many wonderful people to thank for the history of South West Counselling. Jenny Monson, for example, who was instrumental in the successful submission to Lotterywest that enabled us to use the Busselton premises in perpetuity. That caveat has since been removed and SWCI owns the premises. Thank you, Jenny!

The original founders of Mobile Counselling in WA, which was later to become South West Counselling Incorporated, set out in their caravan on May 29th, 1982, to offer support and counselling to townships across WA. This amazing couple were Willi and George Smith, and we are very proud to announce that 86-year-old Willi Smith has agreed to be our patron. As you can

imagine this vibrant and wonderful woman has some interesting insights and observations on the organisation. Please read the article on pages 3 - 4 to read some of those observations from Willi herself.

As we look towards new challenges, we also see new possibilities as an integral part of the community. Our Board is based on mutual trust and respect as is SWCI's approach to its client base. In the last year client feedback reported a 95% beneficial outcome. With the mutually beneficial support and encouragement of the staff, the CEO and the Board of South West Counselling Inc., I see no reason why this shouldn't continue.

Chief Executive Officer's Report

Delivering counselling and support services in today's challenging environment has consistently demanded commitment and dedication to providing the best for our clients and colleagues. The past year has been no exception.

In 2022, South West Counselling celebrated an impressive 40 years of service to the Western Australian community, a testament to the organisation's enduring commitment to its local communities. During the 2022/2023 period, 794 individual clients sought our services, with 357 of them being new clients. Additionally, 162 children and young people under 18 engaged in some of the 1791 counselling sessions during this time.

Our work is grounded in a philosophy that aims to support those grappling with the escalating cost of living, affecting areas such as housing, healthcare, education, and basic necessities. Many families find themselves under financial strain, leading to chronic stress and a sense of helplessness. This crisis has strained couple relationships and is reflected in our client statistics. We've witnessed family separations, parent-child conflicts, domestic violence, depression, anxiety, suicidal ideation, and other mental health issues. Unfortunately, our waiting list remains consistently high, underscoring the strain we face due to being under-resourced to meet the demand, a challenge common to most community services. The burgeoning population in the South West region further compounds our service delivery challenges.

We firmly believe that collaboration among service providers is crucial to achieving optimal client outcomes. The benefits of these partnerships extend to clients, their families, and the broader community. We emphasise cooperation with other services to ensure a comprehensive approach in addressing the diverse needs of our clients.

The South West Counselling Board and staff engaged in a Strategic Planning Day in 2022, charting the course for the 2022-2023 year and including plans to introduce additional income-generating programs to enhance our service delivery. A subsequent Planning Day in February 2023 enabled the team to fine-tune the implementation of these programs, identifying specific professional development needs to equip the team with the necessary knowledge and skills. Throughout the year, staff participated in numerous workshops and training opportunities, as detailed in this report.

New programs implemented during the year include:

- Mental Health Care Plan Counselling through GP referral to SWCI Psychologist.
- Single Session Counselling.
- NDIS Self-Managed or Plan-Managed Counselling.

- Social Worker Advocacy.
- Clinical Supervision.
- Mother-Baby-Nurture Peer Support Group.
- Reestablished the Sexuality & Gender Acceptance (SAGA) Support Group.

Our new Social Worker Advocacy program has successfully separated advocacy work from therapeutic intervention, providing clients with enhanced support for their complex needs. Delivering advocacy within a counselling setting has empowered clients by amplifying their voices, rights, and access to crucial resources. This approach not only benefits individuals but also contributes to systemic change and fosters more inclusive and supportive environments.

South West Counselling's current Service Agreement with the Department of Communities concludes on 31st March 2024. The organisation recently underwent a Service Review and an external consultant engaged by the Department of Communities conducted a comprehensive review to determine the future of our current contract. Notification regarding the outcome of this evaluation is expected to be provided to the organisation by 31st December 2023. As in previous years, this uncertainty leaves the organisation in a precarious position regarding the future of our service.

Finally, I extend my heartfelt appreciation to the entire staff at South West Counselling. Together, we form an incredible team! A special thank you to Bev, our Service Coordinator, and Shantell, our Clinical Coordinator, for your unwavering and unparalleled support. I would also like to acknowledge Gloria Ross and the other Board members for their support throughout the year. Thank you.

- Policy to turn off lights and electrical equipment when not in use.
- Thoughtful adjustment of heating and cooling systems with a focus on minimising energy consumption.
- Prioritising the procurement of environmentally friendly and efficient products whenever feasible.
- Embracing a culture of reusing and recycling wherever possible.
- Utilising environmentally friendly cleaning materials.
- Maintaining a compost bin for organic waste.
- Abandoning the use of plastic bags.
- Transitioning to entirely online client information management, eliminating the need for paper client files.
- Adopting a paperless approach for Board meetings, utilising electronic equipment exclusively.
- Utilising reusable coffee pods and recycling through designated Recycle boxes at the Busselton office.
- Prioritising local sourcing whenever practical.





Service Area

South West Counselling continues to be an integral community service organisation in the South West. We have a reputation for excellence in service delivery and for providing quality, confidential, accessible, and affordable counselling, support and advocacy services to communities across this extensive region. Offices are currently based in Busselton and Margaret River. Locations are reviewed periodically to ensure they continue to provide maximum benefit to local populations. All services are available by face-to-face, zoom or phone contact.





We continue to see clients from a wide geographical area across the South West. Counselling interventions, advocacy, group work, and other supports are provided to individuals, couples, and families, including specialised counselling for children and young people.

Client referrals come from a variety of sources including GPs, government departments, schools, community service agencies, workplaces, and self-referrals. It is estimated that at least 60% of clients access South West Counselling because of previous contact, or at the suggestion of a friend or colleague.


